**GENERAL INSTRUCTIONS FOR RD-111**  
(A separate extension form must be filed for each account)

**Section A**

1. Every resident individual who derives income from an unincorporated business, association, profession, or other business activity may file a profits extension.
2. Every nonresident individual who derives income from an unincorporated business, association, profession or other activity doing business within Kansas City, Missouri may file a profits extension.
3. Every corporation or partnership conducting a business within the city or rendering or performing services within Kansas City, Missouri may file a profits extension.
4. If your earnings are derived solely from salaries, wages, commissions, or other compensations you should complete form RD-112 (Application for Automatic Extension for Wage Earner).
5. The due date for final payment is April 15 for calendar year tax files or 105 days after the end of the fiscal if not a calendar year.
6. **Extension payment must be 90% of the tax due to avoid penalty and interest.**

**Section B**

1. File this form on or before due date of return
2. Complete Section B regardless of whether you are requesting an extension of time to file a profits return. **Extension payment must be 90% of the tax due to avoid penalty and interest.**
3. An extension is granted for a period of six (6) months.
4. This is not an extension of time for payment of taxes. This is a request for additional time to file your return.
5. An automatic extension time to file will be granted upon timely receipt of tax due (line 3C) and a completed application for extension.
6. If the extension to time to file is not granted, you will receive a denial notice.
7. Form RD-111 and estimated taxes are due on or before the due date of return. RD-108 interest and penalties must be paid.
