# **Building Performance Standards Draft Resolution**

Lara Isch gave brief background information on the City's participation in the Building Performance Standards Coalition. A draft resolution was presented to the committee to direct the creation of a Building Performance Standards policy that is equitable to Kansas City. The goal is that this policy will later become an ordinance to address greenhouse gas emissions in our current building stock. The Benchmarking that the city does requires any building owner above 50,000 sq. feet to have to report their energy and water usage data to OEQ but doesn't require them to make energy improvements.

Consuella McCain gave a slideshow presentation explaining the Building Performance Standards Policy process for Kansas City- see attached.

\* Robin Ganahl made a motion, seconded by Bridget Sanderson, to endorse the Building Performance Standards draft Resolution. The motion passed.

# **OEQ** Update-

- 1. Solarize KC update/results:
- Solarize Kansas City- Enrollment ended in October 2022 with 657 signups for bids (estimates) program for residential, commercial, and nonprofits. December 2022 was the cut off to sign up for contracts. Based on the number we have just a little over 100 residential contracts in place.
- Share the Sun- The low- income component of Solarize Kansas City \$20,000.00 has been donated towards the program and the City is contributing \$150,000.00.
- A Request for Proposals was issued a couple of months ago for solar at the airport and the end date for submission has been extended to February 10,2023.
- Energy Code- The City adopted the 2021 IECC a few months ago, becoming the second City in the country to do so. Implementation of that is in July of 2023.
- Budget-Budget has been submitted to the City Manager. The committees will be kept updated with dates for community input process and are encouraged to participate in supporting as they see fit in the hearings.
- Streetlights- LED conversion has started. Lara Isch shared the following link to track the progress:

    - 2. Grant opportunities being pursued:
- ECGB funding- They City has a formula grant for Energy Efficiency Community Block Grants we are going to get about \$477,000 as of Jan. 18, 2023. Lara Isch will be meeting with the Mayor's office staff later this week to discuss priorities and other funding issues.

• The City has two economic development grant proposals outstanding right now. One with Bridging the Gap to help with energy efficiency in small apartment buildings. The other is to help with energy efficiency for houses dealing with long term issues from COVID. We also received a technical assistance grant from The American Council for an Energy- Efficient Economy. We have a NSF Civics grant for trees with three other cities to figure out some of the barriers to implementing trees planting and maintenance. It is a Phase 1 national science foundation grant which is currently funded at \$50,000.00. In March we will be submitting our final grant for a million dollars that will be split between each city to help implementation.
