To all Interested Individuals, Groups and Agencies

Notice is hereby given that the City of Kansas City, Missouri through the Housing and Community Development Department is seeking proposals from qualified applicants for the development of 2023 HOME-ARP program-eligible projects.

The City of Kansas City, Missouri anticipates receiving approximately \$4,797,892.00 in Non-Congregate Low Barrier Shelter funds, \$1,500,000.00 Supportive Services funds, \$419,859.00 Non-Profit Capacity Building funds, and \$419,859.00 Non-Profit Operating funds. The HOME-ARP funding from the United States Housing and Urban Development Department (HUD) total funding amount is \$8,397,188.00. The overall purpose of the funding is to provide homeless and shelter services to the vulnerable households and families in Kansas City, Missouri known as *“qualifying populations”*.

HOME-ARP Projects must meet all of the provisions of 24 Code of Federal Regulations (CFR) Part 92 and must target qualifying populations as defined by HUD 24 CFR 91.5 and must meet the criteria for the established definition of Homeless or At Risk of Homelessness under the McKinney-Vento Act of 2009.
