## **Introduction**

Community Improvement Districts (CID) have long served Kansas City as a means to facilitate redevelopment and provide reinvestment in local communities through funding the provision of a variety of services. Approved by City Council, each CID must garner the support of a majority of property owners as well as property owners collectively owning more than fifty percent of the assessed value of property within the district. There are currently 88 separate CIDs within Kansas City, some of which are dedicated to providing community services and some of which are dedicated to remediating blight and capital improvements.

This report is prepared for City Council under the direction of Ordinance 210565, which was passed January 13<sup>th</sup>, 2022. Requirements for CID reporting originate in State statute, with additional requirements established by the City. This report includes two main sections: an aggregate summary of all CIDs, as well as an appendix identifying each specific CID and whether requirements were met. City staff were directed to prepare this report annually, indicating the degree of compliance of all CIDs related to the submission of annual budgets and annual reports, whether the work performed conformed to previous budgets, and whether the CID met the terms of its cooperative agreement with the City. Each CID was evaluated on the submission of the proposed budget for Fiscal Year 2023 (ending April 2023), as well as the submission of the annual report for Fiscal Year 2022 (ending April 2022). Staff sent out letters and emails in mid-July, attempting to contact representatives of each CID in order to remind each district of State obligations and informing CIDs of new City obligations.

## **Executive Summary**

In the first year of these new Community Improvement District (CID) reporting requirements, compliance with both State and City requirements was intermittent. While the vast majority of CIDs submitted budgets and annual reports (80% and 89%, respectively), only 64% of the submissions were on or before the due date established by State law. Around half (51%) of CIDs submitted a budget that met all requirements while only 11% of CIDs submitted an annual report that met all State and City requirements, with over half of all CIDs (53%) missing multiple components in their annual reporting.

New requirements related to board member contact information were not met by a majority of CIDs, with only 34% of CIDs including both a listing of board members and contact information for those board members. 39% of CIDs either listed board members with no contact information or did not list board members whatsoever. Determining budget conformance between the 2022 annual report and 2022 proposed budget was also a challenge, with only 35% of CIDs conforming to their submitted budget- 33% of CIDs were missing a record of a proposed budget submission for 2022.

The CID program provides for two major types of work to be undertaken by each district: conducting improvements and/or providing services. Improvements consist primarily of blight remediation and are usually dedicated to public spaces. Services encompass a variety of tasks such as snow removal or trash cleanup that improve the overall district but are not geared towards construction. Over half of all CIDs (59%) did not provide services during the 2022 fiscal

year- but of those CIDs not providing services, roughly 63% were formed only to conduct improvements rather than provide services. 29% of the CIDs who did not provide services included language in their formation petition indicating an intention of providing public services. Of all 87 CIDs, only 20% reported what services they provided during the fiscal year. 10% of CIDs provided improvements but did not specify what services were provided in their report.

While a majority of CIDs (57%) provided the date which an annual budget was adopted and when an annual report was submitted, nearly 30% of all districts did not date their annual report submission. Many CIDs failed to provide required submittal dates, with roughly 57% of CIDs failing to indicate the date their proposed budget was submitted to the City. Frequently, submission dates were based upon a filename assigned by the City Clerk due to the lack of dating on submitted materials.

Determination of compliance with cooperative agreements is problematic, as 75% of CIDs could not be confirmed either to have a cooperative agreement in place or locate the cooperative agreement itself. Staff found copies of 22 cooperative agreements, of which an authenticated copy of only 4 agreements could be located prior to preparation of this report. Cooperative agreements have long been a challenge for the CID program, with agreements only being required since 2013 and only for CIDs engaging in improvements to public right-of-way or otherwise supporting business activities and economic development (per Resolution 120605).

## **Recommendations**

After the first year of this process, there are some potential modifications for Council to consider, should they so choose:

1. The Ordinance as written requires a report to be submitted on or around November 1<sup>st</sup> of each year. This report is being submitted to you on November 30<sup>th</sup>, due to the fact that submissions continue to roll in as late as the end of October, nearly 2 months after they are due. Staff would recommend a regular report on or around December 1<sup>st</sup>, in order to ensure that adequate time is allowed to assist CIDs in meeting their reporting obligations and still allow Staff adequate time to prepare a thorough report.
2. The Ordinance requires that contact information be provided for each CID board member, to be entered into the City's board and commissions electronic database. Staff would recommend specifying the provision of an e-mail address, as this would be the least invasive method of communicating with CID board members that still ensures prompt communication and secure delivery. 15% of Districts provided only a mailing address for contact information, which increases costs to the City to communicate with these board members while also running the risk of mail being lost- potentially leading to fines for failure to pay reimbursement invoices in a timely fashion.



## **Aggregate District Findings**

### **Proposed Budget Timeliness:**

Of the **84** Districts required to submit a proposed budget for FY 23, **69 (82%)** Districts submitted a proposed budget and **55 (65%)** were submitted on or before the due date of 1/31.

**14 (17%)** Districts submitted after 1/31.

**9 (11%)** Districts submitted more than 30 days late (not counting non-submittals)

**24 (29%)** Districts did not date submittal- submittal date based on Clerk filename

**15 (18%)** Districts have no record of submitting a proposed budget

### **Proposed Budget Content:**

Of the **84** Districts required to submit a proposed budget for FY 23, **45 (54%)** Districts submitted a proposed budget that met all requirements.

**0 (0%)** Districts did not identify expected expenditures.

**1 (1%)** Districts did not identify expected revenues.

**14 (17%)** Districts did not identify rates of assessments or taxes.

**9 (10%)** Districts met all requirements but submitted after 1/31.

**15 (18%)** Districts have no record of submitting a proposed budget.

### **Annual Report Timeliness:**

Of the **87** Districts required to submit an annual report for FY 22, **79 (91%)** Districts submitted an annual report for fiscal year 2022 and **56 (64%)** were submitted on or before the due date of 8/29.

**23 (26%)** were submitted after 8/29.

**7 (8%)** reports were submitted over 30 days late (not counting non-submittals).

**8 (9%)** Districts have no record of submitting an annual report.

**5 (6%)** Districts met all requirements besides those related to reporting of services, revenues, expenditures, or a detailed breakdown.

**6 (7%)** Districts met all requirements besides date requirements.

**0 (0%)** Districts met all requirements besides board resolutions.

**46 (53%)** Districts did not meet multiple requirements.

**8 (9%)** Districts have no record of submitting an annual report.

### **Board Members:**

Of the **87** Districts required to submit an annual report for FY 22, **32 (37%)** Districts included both a listing of board members and contact information.

**3 (3%)** Districts did not list board members or contact information

**31 (36%)** Districts listed board members but not contact information

**13 (15%)** of the Districts supplied a mailing address in lieu of contact information.

**8 (9%)** Districts have no record of submitting an annual report.

### **Services Provided:**

Of the **87** Districts required to submit an annual report for FY 22, **17 (20%)** Districts state the services provided by the District during the fiscal year.

**9 (10%)** Districts provided services but did not specify what services were provided during FY 22.

**53 (61%)** Districts did not provide services.

Of the above **53** Districts, **33 (62%)** Districts formation petition did not indicate a provision of public services.

Of the above **53** Districts, **15 (28%)** Districts formation petition did indicate a provision of public services.

Of the above **53** Districts, **5 (9%)** Districts did not begin or have not begun collecting revenue.

**8 (9%)** Districts have no record of submitting an annual report.

**Revenues Collected:**

Of the **87** Districts required to submit an annual report for FY 22, **56 (64%)** Districts state the revenues collected by the District during the fiscal year.

**10 (11%)** Districts did not specify the source of revenues.

**11 (13%)** Districts did not list revenues.

Of the above **11** Districts, **8 (73%)** have no identified source of revenue.

**2 (2%)** Districts did not include a budget detailing actual revenue for FY 22.

**8 (9%)** Districts have no record of submitting an annual report.

**Expenditures Made:**

Of the **87** Districts required to submit an annual report for FY 22, **56 (64%)** Districts state the expenditures made by the District during the fiscal year.

**2 (2%)** Districts did not specify the type of expenditures.

**14 (16%)** Districts did not incur any expenses.

Of the above **14** Districts, **6 (43%)** projected no expenses in their FY 22 budget.

**2 (2%)** Districts did not include a budget detailing actual expenses for FY 22.

**5 (6%)** Districts claimed to incur expenses that are not reflected in the FY 22 report.

**8 (9%)** Districts have no record of submitting an annual report.

**Detailed breakdown of public infrastructure, exterior, interior, and other improvements:**

Of the **87** Districts required to submit an annual report for FY 22, **52 (60%)** Districts provided a detailed breakdown of expenditures made by the District during the fiscal year.

**6 (7%)** Districts did not provide a complete line-item budget.

**14 (16%)** Districts did not incur any expenses.

Of the above **14** Districts, **6 (43%)** projected no expenses in their FY 22 budget.

**2 (2%)** Districts did not include a budget detailing actual expenses for FY 22.

**5 (6%)** Districts claimed to incur expenses that are not reflected in the FY 22 budget.

**8 (9%)** Districts have no record of submitting an annual report.

**Additional Info- Already Captured Above**

**11 (13%)** Districts claimed that all improvements were complete before the reporting requirements and adoption of Ordinance 210565.

Of the above Districts, **7 (64%)** have never reported improvements.

Of the **84** Districts required to submit an annual report for FY 22 and a proposed budget for FY 23, **50 (60%)** Districts included the date they adopted their annual budget for FY 23.

Of the above 19 Districts, **2 (11%)** Districts did not adopt an annual budget.
