**Probation Order and Agreement to Pay-Animal**

The above-named defendant, having been found guilty of a violation of a city ordinance, is hereby granted probation, released thereon, and placed under the continuing supervision of the Court subject to the conditions outlined below.

NOW, THEREFORE, in the above-captioned case, the defendant is hereby placed on probation effective this date, pursuant to the following conditions.

For your sentence the court:

Suspends imposition of sentence.

Suspends execution of sentence on your jail term of \_\_\_\_\_ days.

You shall abide by these standard conditions of probation.

1. You shall not violate any KCMO animal ordinance in chapter 14 of the Kansas City, Missouri Code of Ordinances.
2. You shall report in writing to the court clerk any change of your residence address within 7 days from the date of such change.
3. You shall pay all supervision fees, court costs and fines, if any, imposed on this case by the court. All fines, fees and courts costs
4. You shall also abide by any of the following **Special Conditions**:
  - a. You shall complete \_\_\_\_\_ hours of community service through MCSP by \_\_\_\_\_
  - b. Make restitution in the amount of \_\_\_\_\_ by cashier's check or money order delivered to the Violations Bureau.

  - c. Allow city inspections of your animals and property.
  - d. Do not abuse any animal.
  - e. Ensure the adequate provision of food, water, shelter, care and health care for any animal owned, kept, harbored or possessed.
  - f. Do not allow the accumulation of animal feces in the yard and area where animals are kept.
  - g. Do not own, keep, harbor or possess any dog cat animal.
  - h. Do not own or possess within this city the following animals:
  - i. Do own, keep, harbor or possess more than four dogs and/or cats in the city.
  - j. Do not allow your animal to make excessive noise that disturbs a neighbor.
  - k. Securely confine your dog and do not allow your animal to be/run at large as described in KCMO ordinance 14-33.
  - l. Spay or neuter all pitbull dogs owned, kept, harbored or possessed in the city.
  - m. Procure a license for all dogs owned, kept, harbored or possessed in the city.

I understand and agree to the terms and conditions of probation. I fully understand that if I violate any of the conditions, the court may revoke my probation and impose sentence and/or order the execution of sentence previously imposed. I further understand that without further notice, failure to pay fines, fees or costs due may result in future tax refunds being intercepted for past due amounts and/or delinquent amounts being turned over to a collection agency.
