You shall abide by these standard conditions of probation.

1. You shall not violate any federal, state, county or municipal law or ordinance which is punishable by a fine and/or jail sentence.
2. You shall report in writing to the court clerk any change of your residence address within 7 days from the date of such change.
3. Defendant shall report to the Offender Accountability Coordinator as directed.
4. Defendant shall follow all directives given by the Offender Accountability Coordinator.
5. Defendant shall report to the Compliance Docket as scheduled.
6. Defendant shall attend programming and treatment as directed.
7. Defendant shall notify the Offender Accountability Coordinator prior to any absences.
8. Defendant shall not consume or possess any controlled substances unless prescribed by a licensed medical practitioner.
9. Defendant shall submit to random drug and alcohol testing.
10. Defendant shall pay all court costs, fines, supervision and program fees as ordered by the court. All fines, fees and court costs are due within 60 days of this Order unless other arrangements are made at the Violations Bureau.
11. Defendant shall not possess or purchase any firearms or ammunition.
12. You shall also abide by any of the following **Special Conditions**:
 - a. You shall not have any contact with any victim or witness on this case, or their families, nor shall you enter upon their residential or business premises, without the express consent of said victim, witness or business.
