- (2) Staff comments will be progressively updated on CompassKC under the 'Reviews' tab. Your planner will compile these comments and attach them to your case by the specified deadline. Comments are categorized as Corrections, Recommendations, or Conditions.
- (4) The Development Review Committee (DRC) is a scheduled meeting where applicant teams can discuss their applications with city stakeholders. Attendance is mandatory for cases that require the DRC process, UNESS excused by the City Planning and Development Director. Failure to attend will delay your application until you can appear at the next scheduled DRC meeting. The meetings are virtual, and a pinning link will be provided on two day in advance of the meeting. Due to a high case where the committee is a second or committee, the propagate or discuss only staff comments you be flagged in your prior response letter. - (11) The staff report related to your application will be available on CompassKC. This report will be prepared by your assigned planner and contains staff analysis and recommendations. This is the document that the CPC will consult in preparation for the meeting, you are encouraged to review it.
- (12) The CPC hearing is scheduled for this date. Attendance by the property owner or an authorized representative is mandatory. The hearing is hybrid, allowing for in person attendance at City Hall or via Zoom (links available on the CPC webpage). The CPC will make a final decision for most application types, except those specified in (13) and (15), where they will provide a recommendation.

 (13) The IZR hearing is scheduled for this date. Final decisions on Special Use Permits are made by the Board of Zoning Adjustment following a recommendation from CPC. Attendance by the property owner or an authorized representative is mandatory (authorization for representation before the BZA must be via a naturated diffident.

 (14) This is the earliest date the City Council could introduce your case. This date is filely (but not guaranteed) if all plan corrections are completed before the CPC hearing. If corrections are pending, revised plans must be approved by staff before scheduling with the Council Your assigned planner can confirm dates post. CPC.
