**PROPOSED PLAN SUMMARY**

The 2024 Annual Action Plan will be year three of the HUD approved Five-Year Consolidated Plan (2022-2026). The entitlement recommendations are summarized below and available for public review and comment. The Plan’s primary strategies include:

- To the greatest extent possible, provide program assistance to the strategic target areas identified in the Five-Year Consolidated Plan which are largely east of Troost; creating and implementing partnerships for housing rehabilitation
- Provides assistance for the development of affordable rental housing, single family housing, public services; and public facilities;
- Maintains housing and public service options for homeless persons, especially for families with children, through the existing network of providers; and
- Maintains the provision of services to persons with HIV/AIDS in the eleven-county area.
