Subject: Interim Report - City Consultant Services Expenditures May 1, 2008 to March 12,

2009

You asked for information about the city's consultant expenditures, including legal services, in fiscal year 2009.

Summary

From May 1, 2008 through March 12, 2009, 16 departments expensed about \$4.7 million to the consultant services account. Approximately \$2.6 million in various court and legal service costs were expensed to the legal services accounts. Additional audit work would be required to confirm all these expenditures represent fees for consultant services and outside legal counsel and identify the nature of the services these firms provided to the city. In addition, there could be consulting or legal costs that were charged to other accounts and those costs would not be included in our figures.

Work Performed

We obtained and reviewed data for expenditures charged to consultant and legal services accounts from the city's financial management system. The expenditure data we reviewed covered May 1, 2008 to March 12, 2009, and was coded to three accounts in the financial management system: consultant services, court costs and legal services, and legal services. If consultant or legal services costs were not coded to these accounts, they were not captured by our system queries. In addition, there could be costs charged to these accounts that may not be for consulting or legal services

Results

Almost \$4.7 Million Charged to Consultant Services Expenditures During Fiscal Year 2009

During the current fiscal year, 16 departments recorded expenditures to the consultant services account. Total departmental expenditures range from about \$3,000 to \$1.1 million. (See Exhibit 1.)

Consultant services payments were made to 102 different vendors; 43 vendors received \$20,000 or more. (See Attachment 1.)

While about \$4.7 million was expensed to the consultant services account, we cannot confirm that all these costs represent payments for consultants without additional audit work, including reviewing contractor payment documents associated with these expenditures. Identifying what the city expected to receive and confirm it was delivered would also require additional audit work.

Legal Expenses Total Almost \$2.6 Million

Legal expenses in the current fiscal year include miscellaneous court fees and legal costs in addition to fees for outside legal counsel. Departmental expenditures for legal services range from \$200 to \$1.7 million. (See Exhibit 2.)
