The Kansas City Missouri Health Department's Air Quality Program is hosting a Visual Emission Training (Smoke School) this Spring. As a reminder, this training is required by the Environmental Protection Agency (EPA) for all facilities producing emissions into the ambient air.

The Spring session of Smoke School is schedule from October 23rd - 24th. In the case of rain, the make-up day will be held on October 25th. The training is conducted at the Public Works facility, located at 4725 Coal Mine Rd, Kansas City, MO 64130. Please see the attached map for reference and directions.

The opacity reading practice runs will begin at 8:30am and end at 9:00am. The test runs will begin at 9:00am and end at 4:30pm daily.

Please fill out the enclosed application per attendee. You many duplicated the form as necessary. The complete application should be accompanied with a non-refundable registration fee of \$150.00. Registration and payments can be done online on https://www.kcmo.gov/city-hall/departments/health/smoke-school, or sent by mail to Air Quality Program located at 2400 Troost Avenue, Kansas City, MO 64108, suite 3200. Checks or money orders can be made to the City Treasurer of Kansas City, Missouri.


