Board Member Bacchus moved that the economic development project proposed by Linwood Gardens for 32 units of affordable housing units for domestic violence survivors and shared community kitchen and coffee shop at Linwood & Bruce R Watkins Drive be recommended to the City Council for approval and that it be funded in the amount of \$1,150,000. Board Member Bacchus moved that the economic development project proposed by Urban Neighborhood Initiative for site preparation and infrastructure improvements for 30 units of housing to be constructed in partnership with habitat for Humanity be recommended to the City Council for approval and that it be funded in the amount of \$250,000. Board Member Patterson Hazley seconded the motion. Board Members Hardwick, Patterson Hazley, Bacchus and Brown voted in the affirmative.

Board Member Bacchus moved that the economic development project by KC Town Hall for renovation of an existing building for 4 retail spaces and 3 apartment units at 36th & Indiana be recommended to the City Council for approval and that it be funded in the amount of \$490,539. Vice Chair Patterson Hazley seconded the motion. Board Members Hardwick, Patterson Hazley, Bacchus and Brown voted in the affirmative.

Board Member Bacchus moved that the economic development project proposed by UrbanAmerica EVE, LLC for construction of 36 carriage homes at 21st & Woodland and stabilization of "The Castle" on Vine Street be recommended to the City Council for approval and that it be funded in the amount of \$1,205,231. Board Member Brown

seconded the motion. Board Members Patterson Hazley, Bacchus and Brown voted in the affirmative. Board Member Hardwick recused himself.

Board Member Bacchus moved that the economic development project proposed by UrbanAmerica Southpointe, LLC for pre-construction dollars for mixed-use development at 63rd & Prospect be recommended to the City Council for approval and that it be funded in the amount of \$500,000.
