
ORDER

1. I am the Presiding Judge of the Kansas City Municipal Division of the Circuit Court for the 16th Judicial Circuit of Missouri.

4. I hereby adopt and include the attached list of violations and the corresponding fines, in addition to those set forth in the Uniform Fine Schedule, as established by Supreme Court Rule 37.495.
