- B. *Minutes Michael Kelley made a motion, seconded by Caroline (Molly) Davies, to approve the minutes of the meeting of May 2021. The motion passed.
- C. Climate Protection & Resilience Plan Update Lara Isch
 - Two climate justice workers have been hired and the intern should be hired soon.
 - Working groups for six sectors of the climate plan are in the process of being formed.
 - OEQ is working with consultants to begin the GHG inventory.
- D. EMC Annual Report Carol Adams
 - Highlight to the Mayor/City Council what EMC has in process as a letter or report format:
 - o Purpose: to get Council prepared for what is next.
 - o Introduce the importance of sequestration and soils.
 - *Please send Carol Adams your thoughts and ideas, the more ideas the better.
- E. Soil Building and Climate Change Marty Kraft
 - Mindset/paradigm shift is needed.
 - Subgroup had a meeting with 6 in person and 6 on zoom.
 - Goal: share ideas in a clear and compelling manner.
 - How to take the information and turn it into action.
 - Molly Davies has offered to redo the Johnson-Su PowerPoint to be more accessible.
 - Ben Proffer offered his video production skills to help with this project.
 - Reaching rural Ag as well as urban Ag must be a priority.
 - Not one solution, but an aggregate of solutions.
 - Powell Gardens is finishing a master plan which includes several hundred acres devoted to regenerative Ag.
- F. Office of Environmental Quality Report Andy Savastino & Lara Isch

- EMC and CPSC Appointments Mayor's office has acknowledged that recommendations have been made but the mayor has not made his appointments.
- Environmental Achievement Awards only 1 or 2 nominations have been made so far with a deadline
 of June 18th. Does the commission agree to extend deadline if no more submissions have been made
 at that time? Carol Adams leaves that to OEQ discretion.
- DOE funds Jerry gave a presentation and City Council approved the project to go forward.
- LEED For Cities/CDP Staff is working on reporting for both.
- Benchmarking Surpassed compliance date, but OEQ is still reaching out for more submissions.
- This past FY we had the lowest rate of "Opportunities for Improvement" compliance issues in the last 20 years.
- Public Works is working on the parameters for the LED Streetlight Conversion pilot program.

 - 50 air quality sensors are deployed along a corridor that runs from Front St to 85th St, between 71 HWY & Main St.
