Installation, maintenance, repair, servicing, and testing of all sanitary plumbing and potable water supply piping, and appliances connected thereto, including gas piping, and the complete installation of water heaters; the installation of piping for transmission of chemicals and gases where regulated by this code; the installation of gas ranges, domestic gas incinerators, gas dryers, and other gas-fired appliances; the installation of steam heating plants carrying pressures not exceeding 15 pounds per square inch gauge steam pressure; the installation of hot water heating plants carrying pressures not exceeding 30 pounds per square inch gauge hot water pressure; and installation of low-voltage wiring not exceeding 48 volts for gas-fired appliances and water heaters when such wiring is not enclosed in conduit or raceway.

I also attest the individual has experience in both residential and commercial plumbing applications and that such experience also includes the installation, maintenance, repair, and testing of backflow prevention devices; tying into and/or installing water and sewer mains; installing, maintaining, and/or repairing septic tanks and related lines; and performing septic system change outs, in addition to the items listed above.

I affirm that all of the applicant's plumbing trades experience has been legally gained in the direct employ of one or more licensed contractors.
