Bill Griffith – Retired teacher, Lived in KCMO for 6 years, Involved in environmental work as a volunteer since 1993 - Renewable energy, energy efficiency, and rural utility cooperative focus. Sierra Club involvement.

Bridget Sanderson – Lifelong KC resident, Works for Environment Missouri - A citizen-based environmental advocacy group, worked as a soil scientist for state of KS.

Kristin Riott – Served as Executive Director of Bridging the Gap for 11 years, lots of work related to climate change preparation and remediation - urban forestry, energy & water efficiency.

Michael Kelley – Policy Director for BikeWalk KC, also on Environmental Management Commission and liaison to that commission.

Robin Ganahl – Born in KC, went to KU, moved back 2 years ago, background as an Environmental engineer, Clean energy & community choice energy advocate, currently part of Mothers Out Front as a local organizer - voice for kids and concerned moms.

## **KC Climate Protection and Resiliency Plan**

Status Update, Public Outreach and Schedule

- History
  - KC has had a climate protection plan since 2008
- 2020 goals needed to be updated Resolution No. 200005
  - o Municipal operations climate neutral by 2030; community-wide climate neutral by 2040
  - Need for changes at the utility scale; also changes needed in the building, energy & transportation sectors
  - Mitigating the climate impacts is no longer a sole focus; need to also look to build a resilient city and adapt to changing climate
- Outreach to many groups is critical to this process, there was a project overview to CPSC at the June meeting can revisit that video if desired (reach out to Rachel O'Neal for the recording)
- CPRP markers
  - Build on existing data within city and regionally
  - Deeper neighborhood & community understanding
  - Actionable solutions and implementation partners
- Timeline working to update the plan in 2021-2022 with the long term goals noted above
- Climate Action Framework
  - Double down on emissions reduction work
  - Growing adaptation & resilience to climate change impacts
  - Working with, not for community through this process
- What Impacts are Expected?
  - O Does the data align with lived experiences?
  - Severe heat events
  - Flooding
  - Climate migration
  - Air quality
  - o Disease
- Committed to hearing the voices of all Kanas City residents
- Human-driven, equity-centered approach
- Climate Justice Workers role is to make sure the process and outcomes are equitable

- The main foundation is to understand the definition of climate equity adapted a definition that includes prioritization of historically marginalized communities and acknowledges the need to help communities heal through this process
- Leveraging MARC's research & mapping of local risks & vulnerabilities to identify target areas for outreach
- Climate Justice Workers
  - facilitators and trust builders in this process
  - Plan to engage:
    - Historically marginalized groups and neighborhoods
    - CPSC
    - Technical advisors (including city staff)
    - Elected and appointed officials
    - Organizational partners
    - Public
  - Keeping track of various metrics to make sure we are accountable to this process
  - Facilitators for the community uplift, amplify and bring others into the process
  - Want the community to feel like this is their plan and they have a part to play
- Important to have different engagement points and methods for qualitative and quantitative data
- Wanting to connect the dots to what others are doing
- Online engagement doesn't supplant other types of engagement
- Couple climate-related information with other community challenges
- Phase 1 Listen & Learn May through August 2021
- It's important for CPSC members to actively share these links & information to reach every part of the community! Also, please share your climate stories! <a href="KC Climate Protection & Resiliency">KC Climate Protection & Resiliency</a> Plan | KC Spirit Playbook (kcmo.gov)
- What have we heard so far?
  - Black community: common interests around near-term action related to urban heat planting trees, community gardens, access to cooling centers
  - Civic and civil rights organizations are well-equipped to address interconnected and climate justice issues
  - Meeting the community where they are
  - Core infrastructure improvements flooding & transportation
  - Also need to consider gentrification that happens alongside climate solutions
  - Bridging the Gap Leak Stoppers & Urban Forestry program example of existing & immediate community solutions
  - Phase 2: Collaborate & Explore What solution ideas do you want to see? Especially at a neighborhood/hyper-local level
  - Phase 3: Prioritize & Align What's going to have the most impact? What are the priorities?
  - Phase 4: Mobilize begin acting on these priorities
  - Need CPSC help to move the needle politically
- Welcome other suggestions for other events to talk to people about climate change issues CPSC Questions and Discussion
  - What are the targeted areas?
    - Maps developed by MARC and zoomed in by Brendle Group (e.g., high heat areas in NE)
  - What is the framework for prioritization?
    - o Emissions reduction potential (leveraging regional work) plus community interests and priorities
  - What is the CPSC role?
    - Need to hear from the CPSC about their desired frequency and role and then determine how do we deliver on that

- CPSC may want to have their own meetings to evaluate what is presented and consider issues
- What is the proposed schedule for check-ins with Brendle and CPSC?
  - o Late September end of Phase 1
  - End of November between phase 2 & 3
- Are evictions or utility shut offs part of this discussion?
  - o This is a great point and will be added, it also overlaps with issues regarding energy efficient homes.
- Engagement of private funding must be a key part of the strategies that come out of this plan.
  - o Identification of additional funding sources was written into the contract with Brendle and the plan is to have more focused and concise strategies.

### **Future Meetings**

- Frequency
  - o September between phase 1 & 2
  - o November between phase 2 & 3
  - o January Final Review
  - o Thinking of meeting monthly while the climate plan is in motion, like the poll option for selecting the date.
  - Would like at least 10 days' notice for upcoming meetings or call for agenda items.
- Topics
  - o OEQ to fill in CPSC in on Brendle progress
  - o Andy will work with the chair (Tom Grever) to set up the agenda. Please send potential agenda items to the chair.

#### **Public Comments**

- Reaffirming that we are in the midst of a climate crisis.
- IPCC report may seem dire, humans have the power to right the ship.
- Consider a declaration of Ecological Emergency (with EMC or standalone)
- Regional Climate Planning effort is also happening now
  - o This will be presented to the council in September
