Climate Protection & Resiliency Plan (CPRP) Discussion

*Bill Griffith made a motion, seconded by Kristin Riott, to break into subcommittees to review and offer recommendations back to the full committee on the draft Climate Protection & Resiliency Plan (CPRP). The motion passed.

- Is there an opportunity to specifically state in the plan the need to intertwine various types of transportation going forward? Right now, the strategies are separate but in the introduction of that section it can be mentioned how they will work together.
- Dividing the city into North, Central and South doesn't reflect the income disparities in Kansas City. Can we use strategies and actions to address this? It needs to be acknowledged in the plan.
- Prioritization framework scoring was intentionally left out of the plan by The Brendle Group. A committee member feels that putting this in the main plan would be powerful and recommends adding it to the plan.
- Robin Ganahl will lead a subgroup about how the prioritization framework scoring was completed and what the criteria was.

Public Comments

- The Brendle Group has prepared climate plans for many other cities and communities. They also used a lot of previous information collected from the regional plan. OEQ has researched many climate plans from across the country.
- There will not be public seats available for the subgroups to review the different sections of the plan.

Next Steps

- Polls will be sent out to arrange meeting times for subgroups by Chris Hays in OEQ. Subgroups will be limited to 4 people per group.
- Signup sheets will be sent out tomorrow.
- Subgroups should have recommendations prepared for the rest of the committee to review on Wednesday, February 23rd so that there is time for everyone to review and discuss at the meeting scheduled on February 28th.
- Recommendations made to The Brendle Group should be in writing.
- Draft going to the public will include recommendations from CPSC.

*Bridget Sanderson made a motion, seconded by Michael Kelley, to break into subgroups that will form recommendations to share with the committee as a whole by February 23rd. The committee will review each subgroups recommendation and discuss at the meeting scheduled for February 28th and vote on which recommendations should be submitted to The Brendle Group. The Brendle Group will work on updating the plan with the committee's recommendations for 2 weeks and then submit the revised draft to the public for their one-month comment period. Committee can make additional comments during the public comment period as well. The motion passed.
